Applicant understands that during the course of instruction, instructors of IMPACT Stunts and Wushu Inc., other participants or authorized persons will be engaged in a course of conduct requiring physical contact. Applicant gives full consent to such contact as is required by the training.

Applicant understands that strict observation of the rules and regulations relative to training may include the use of protective equipment required by IMPACT Stunts and Wushu Inc. This equipment will largely eliminate the possibility of accident or injury, however, IMPACT Stunts and Wushu Inc. does not warrant the protective equipment.

Refund Policy

Refunds must be requested. You will be refunded based on time missed and only by request. Refunds will be forfeited if requested more than one weeks after the last day of the Seminar.

If you are absent without 24 hours notice prior to the class dates and miss the classes for which you signed up for, you will NOT be refunded the tuition costs.

If you are absent with 24 hours notice prior to the class dates for which you signed up for, you will be refunded the full amount including the deposit.

If IMPACT Stunts cancels the seminar for any reason, you will be refunded the full amount.

If you are expelled from the seminar you will not receive a refund.

Seminar Rules

- Participants of the Glen Levy Martial Arts Seminar must show respect to all instructors at all times. Any participant who shows instructors disrespect will be expelled immediately.
- A response to an instructor who gives you a correction is required to show that you heard the correction. Corrections may help to prevent injury so it is important to let the instructor know you heard them.
- Participants must treat all other participants with courtesy and respect.
- Sexual harassment will not be tolerated and offenders will be expelled immediately.
- Intentional destruction, defacement, or theft of IMPACT Stunts, IMPACT Studios, or Wushu Inc. property or equipment will result in immediate expulsion not excluding legal action.
- Clothing that allows for athletic movement should be worn. Proper shoes for such training should be worn.
- Video filming of the seminar is not permitted.
- Participants must not force, taunt, dare, or pressure in any way a fellow participant to perform a technique that that person chooses not to perform. Serious injury or death may result from such behavior. Offenders will be expelled immediately.
